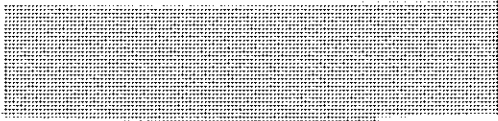

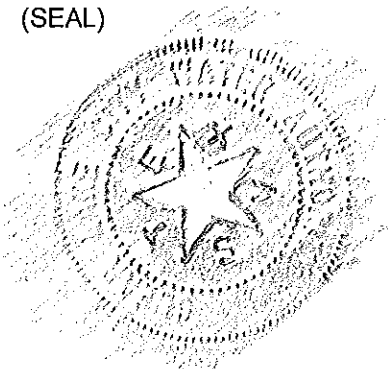
1. Review and approve conservation easement agreement with Galveston Bay Foundation;

- 3. Conservation Easement with Galveston Bay Foundation Approved

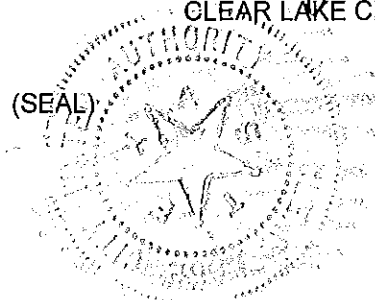
