2. Privilege of Encroachment for HEB at El Dorado and Clear Lake City Blvd.

Mr. Tyler Munsen and Mr. David Lecky presented to the Board a request for sign encroachments at the HEB site. Public comments were received from several Pinebrook residents speaking against the height of the proposed HEB sign. This item was tabled for discussion during Closed Session for real estate matters.
