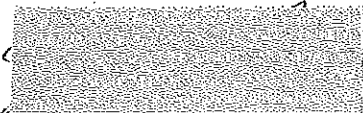

The Board of Directors of the Clear Lake City Water Authority convened in special session open to the public at the Clear Lake United Methodist Church – Wesley Center, at 16335 El Camino Real at 7:00 p.m. on the 24<sup>th</sup> of January 2012 for a town hall meeting. 1. Town Hall Meeting  
The purpose of this town hall meeting is to discuss and receive community input on the future use and design of the CLCWA Storm Water Control and Detention Area at the former Clear Lake Golf Club site. Approximately 105 guests attended.
2. Introduction of Board Members and Special Guests  
Director Branch introduced the list of people named above.
3. Recognition to Exxon Land Development  
Director Savely presented an appreciation award to Exxon Land Development for their commitment to defend and support the local community.
4. Recognition of CLC Civic League  
Director Savely recognized and thanked the Green Space Committee for their dedication and support for the CLCWA Storm Water Control and Detention Area.
5. Recognition of Clear Creek Community Church  
Director Branch introduced and recognized Pastor Karl Garcia and Intern Ryan Lehtinen for organizing and carrying out such a large volunteer event in November 2011. Over 500 members participated in the community service clean-up project at the site of the former golf course.
6. Introduction of Volunteer Adopt-A-Section Coordinator  
Director Branch announced Mr. Bob Palmer would be coordinating volunteers for Adopt-A-Section and general clean-up of the CLCWA Detention Area. A corresponding form was available for interested participants at the meeting and it will be available on CLCWA's website.
7. Purpose of Citizen Forum  
Director Branch discussed the purpose and importance of CLCWA obtaining the property and explained the process involved for design and construction of the detention ponds first, then recreational amenities incorporated. Director Branch stated

CLCWA's desire to work with Harris County and the City of Houston as a joint project to provide the maximum benefit to the citizens.

8. Explanation of Forms

Director Savely explained the three new forms available at the meeting and on CLCWA's website. The Group/Organization Input Form is meant for a single point of contact to complete the form for a group or organization requesting a specific use. The Individual Input Form is an opportunity for residents of the local community to share their ideas and concerns on the area. The Volunteer Adopt-A-Section Form is for the Volunteer Coordinator to contact anyone who is interested in volunteering to clean-up.

9. Introduction of Multi-purpose Advisory Group Co-Chairs



10. Citizen Input


